Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the actions entitled Square, Inc. v. City and County of San Francisco et al., San Francisco County Superior Court, Case Nos. CGC-19-579061 and CGC-20-586039, by the payment of \$2,625,000 to Square, Inc. and the agreement that Square, Inc. and its related entities will not take certain filing positions with respect to their gross receipts taxes for tax years 2019 and 2020. The lawsuit involves a refund of gross

receipts taxes paid by Square, Inc. to the City and County of San Francisco.

Section 2. The above-named actions were filed in San Francisco County Superior Court on September 6, 2019, and August 18, 2020, and the following parties were named in both lawsuits: Plaintiff Square, Inc. and Defendants City and County of San Francisco and José Cisneros, Treasurer and Tax Collector of the City and County of San Francisco.
