4 **Resolution retroactively authorizing the Department of Public Health to accept and**
5 **expend a grant amendment to increase the amount of \$57,564 for a total of \$127,696**
6 **from the Centers for Disease Control and Prevention through the Regents of the**
7 **University of California, San Francisco for participation in a program, entitled**
8 **“Targeted Human Immunodeficiency Virus/Tuberculosis Strategic Information**
9 **Technical Assistance for President's Emergency Plan for Acquired Immunodeficiency**
10 **Syndrome Relief (PEPFAR) and Global Fund to Fight Acquired Immunodeficiency**
11 **Syndrome, Tuberculosis and Malaria (GFATM) Countries,” for the period of**
12 **September 30, 2019, through September 29, 2021.**

14 WHEREAS, The Centers for Disease Control and Prevention (CDC), through the
15 Regents of the University of California, San Francisco (UCSF) as a pass-through entity, has
16 agreed to fund the Department of Public Health (DPH) in the amount of \$127,696 for
17 participation in a program, entitled “Targeted Human Immunodeficiency Virus/Tuberculosis
18 (HIV/TB) Strategic Information Technical Assistance for President's Emergency Plan for
19 Acquired Immunodeficiency Syndrome (AIDS) Relief (PEPFAR) and Global Fund to Fight
20 AIDS, Tuberculosis and Malaria (GFATM) Countries,” for the period of September 30, 2019,
21 through September 29, 2021; and

22 WHEREAS, DPH will support Myanmar Project needs; and

23 WHEREAS, As part of the scope of work, DPH will provide technical assistance on
24 Human Immunodeficiency Virus (HIV) surveillance related activities and facilitate or co-
25 facilitate in-country trainings and workshops; and

1 WHEREAS, DPH will be responsible for developing study and training materials; and

2 WHEREAS, A grant increase of \$57,564 from \$70,132 was approved for the period of
3 September 30, 2020, through September 29, 2021; and

4 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

5 WHEREAS, A request for retroactive approval is being sought because DPH received
6 the full award agreement on February 8, 2021, for a project start date of September 30, 2019;
7 and

8 WHEREAS, The grant includes a provision for indirect costs in the amount of \$13,681;
9 now, therefore, be it

10 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
11 in the amount of \$127,696 from the CDC through the UCSF; and, be it

12 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
13 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

14 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
15 Agreement on behalf of the City; and, be it

16 FURTHER RESOLVED, That within thirty (30) days of the Grant Agreement being fully
17 executed by all parties, the Director of Health shall provide a copy to the Clerk of the Board of
18 Supervisors for inclusion in the official file.
