**Vacant Seat 2**, new appointment, indefinite term, shall be broadly representative of the communities of interest, neighborhoods, and diversity in ethnicity, race, age, gender, and sexual orientation of the City and County of San Francisco.

**Vacant Seat 3**, new appointment, indefinite term, shall be broadly representative of the communities of interest, neighborhoods, and diversity in ethnicity, race, age, gender, and sexual orientation of the City and County of San Francisco.

**Report:** The Task Force shall be responsible for redrawing supervisorial district lines in accordance with the law and shall make appropriate adjustments based on public input provided at community meetings.

**Sunset Date:** The Task Force shall terminate by operation of law after it has completed its duties in connection with the 2020 decennial census, as set forth in Charter, Section 13.110(d).
