Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Shanay Jones v. City and County of San Francisco, United States District Court – Northern District, Case No. 19-cv-07921 by the payment of \$80,000. The lawsuit involves an alleged prescription medication error. City and County of San Francisco agreed to pay for any unreimbursed medical costs related to Shanay Jones' care at Zuckerberg San Francisco General Hospital as to Ms. Jones' medical care from January-February 2018 in addition to the \$80,000 payment.

Section 2. The above-named action was filed in United States District Court – Northern District on January 6, 2020, and the following parties were named in the lawsuit: Plaintiff: Shanay Jones, Defendants: City and County of San Francisco and Dr. Sona Aggarwal.
