

Re:

Our office represents Mollie Stone's Market ("Mollie Stone's"), the project sponsor of a new Mollie Stone's grocery store at 1600 Jackson Street (the "Project"). Mollie Stone's applied for a building permit for the new store on November 21, 2019, which is under review by the Department of Building Inspection (BPA No. 2019.11.21.7869). The Planning Department issued a Class 32 Categorical Exemption Determination for the Project on June 30, 2020 (Planning Case No. 2019-022328ENV).

Mollie Stone's is seeking a type-21 (off-sale general) license from the California Department of Alcoholic Beverage Control ("ABC"). Mollie Stone's has filed an application with the ABC for a license transfer. The type-21 license would be transferred from H&W Liquors located at 801 Hayes Street (previous license No. 21-540207). Due to the overconcentration of this type of ABC license in this census tract and the Project's location in a high crime reporting district, Mollie Stone's must obtain a determination by the Board of Supervisors that the public convenience and necessity will be served by the issuance of this license for operations at 1600 Jackson Street.

The Project will establish a locally owned and operated full-service grocery store at 1600 Jackson Street, within an existing building at the corner of Jackson and Polk Streets. The existing commercial building has been vacant since 2014. Mollie Stone's proposes interior renovations to the first and second floors to convert approximately 44,748 square feet of the existing retail space to a new grocery store, including a coffee shop with a patio and back of house space. The Project would provide 45 on-site parking spaces in an existing below grade garage. Six Class 2 bike spaces would be provided on each of the Project's two street frontages.

The grocery store will sell daily-needs goods to neighborhood residents, including a wide variety of food and household products. Typical business hours will be approximately from 7 a.m. to 10 p.m. daily, with the coffee shop opening at 5:30 a.m. Business hours may be extended in advance of major holidays to accommodate increased demand and for the convenience of customers.

Mollie Stone's was founded locally in 1986 and a majority of employees are union workers. With roots in healthy, natural and specialty foods, Mollie Stone's stores provide a place where customers can get their natural and organic produce, meats, health and beauty products, and also conventional necessities and popular name-brand products. The new grocery store at 1600 Jackson Street will offer that same range of grocery products—including produce, fish and meat, cheeses, dairy, frozen food products, household items, and alcohol. Including beer, wine, and liquor in the store's offerings would serve the public convenience and necessity by increasing the variety of goods offered at this location—bringing a truly full-service grocery store to the neighborhood.

The new Mollie Stone's will provide area residents and visitors with a convenient "onestop" shopping option. While there are six other establishments in the census tract with off-sales licenses, none are full-service grocery stores. For the most part, they are specialty stores including a cheese shop, wine shop, and liquor stores. While there are two markets in the neighborhood, they are small "corner" markets with limited inventory without the wide variety of goods that will be available at the new Mollie Stone's store. Mollie Stone's would be the only full-service grocery store with an off-sale license in the census tract.

Including alcohol in the offerings of this store would also serve the public convenience and necessity by establishing an alcohol retailer that has a vast experience with the sale of alcohol and is a responsible retailer with an effective training and management policy and equipment for controlling the sale of alcohol. Mollie Stone's will extensively train its employees related to alcohol sales at new hire orientations, including acknowledgement of the store's alcohol sale policy. The store will be equipped with smart registers programmed to lock upon an alcohol sale until the cashier enters the customer's birthdate to confirm she/he is of age before proceeding. In addition, the store will be equipped with a state-of-the-art camera system with 90-day memory storage.

Mollie Stone's has completed the ABC noticing requirements pursuant to state law. Mollie Stone's sent a mailed notice regarding the proposed ABC license to all residents within 500 feet of the Project on September 18, 2020, and posted notice on the Project site on September 17, 2020. Mollie Stone's has received a favorable reaction by the neighborhood to the store.

For the reasons outlined above, I respectfully request that this letter be forwarded to the Public Safety and Neighborhood Services Committee of the Board and that the Committee and the full Board of Supervisors make a determination under California Business & Professions Code §23958.4 that the public need or convenience would be served by the issuance of a type-21 off-sale general license to this Mollie Stone's location.
