WHEREAS, The Department of Public Health ("DPH") currently operates the Jail
Health Services (JHS) Administration Center at 650-5th Street (the "Property"), providing
overall comprehensive and integrated system of medical, psychiatric and substance abuse
services to inmates in the San Francisco Jails; and

16 WHEREAS, The City and County of San Francisco ("City", as tenant) originally entered into a lease dated May 9, 2016 (the 'Original Lease"), with Townsend Associates, LLC (as 17 "Landlord") of approximately 3,060 square feet of space ("Premises") for use as the JHS, a 18 19 copy of the Original Lease is on file with the Clerk of the Board in File No. 160710; and WHEREAS, The Original Lease will expire on June 30, 2020, and the Real Estate 20 21 Division ("RED"), in consultation with DPH and the Office of the City Attorney, negotiated an 22 amendment to the Original Lease (the "First Amendment") to amongst other things, extend the 23 term of the Original Lease, a copy of the proposed First Amendment is on file with the Clerk 24 of the Board in File No. 210737; and

1	WHEREAS, The First Amendment extends the term of the Lease (collectively, the
2	Original Lease and First Amendment are the "Lease") until June 30, 2026, plus two additional
3	options of one year each for the City to further extend the term (the extension "Options") at
4	95% of fair market rental value; and
5	WHEREAS, Base rent under the First Amendment will be \$159,200 per year, or
6	\$14,790 per month (\$4.33 per sq. ft.), increasing annually by 3%; and
7	WHEREAS, All other terms and conditions of the Lease will remain in full force and
8	effect, including, among other things, City's obligation to pay for its utility usage; and
9	WHEREAS, The Director of Property determines the rent payable under the First
10	Amendment to be at or below fair market rental value; now, therefore, be it
11	RESOLVED, That in accordance with the recommendation of the Director of Health,
12	the Director of Property is hereby authorized to take all actions on behalf of the City to
13	execute the First Amendment (including exercising the Options); and, be it
14	FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of
15	Property to enter into any amendments or modifications to the Lease (including without
16	limitation, the exhibits) that the Director of Property determines, in consultation with the City
17	Attorney, are in the best interest of the City, does not increase the rent or otherwise materially
18	increase the obligations or liabilities of the City, are necessary or advisable to effectuate the
19	purposes of the lease or this Resolution, and are in compliance with all applicable laws,

LEASE AMENDMENT

THIS AMENDMENT (this "Amendment") is made as of ______, 2021, in San Francisco, California, by and between TOWNSEND ASSOCIATES LLC a California limited liability corporation ("Landlord") and the CITY AND COUNTY OF SAN FRANCISCO, a municipal corporation ("City" or "Tenant").

RECITALS

THIS AMENDMENT is made with reference to the following facts and circumstances:

A. City and Landlord have previously entered into an existing lease agreement, dated as of May 9, 2016 (the "Original Lease"), for the lease of a portion of the building located at 650 Fifth Street (the "Building"), San Francisco, California.

B. Landlord has leased to City the premises in the Building identified in the Basic Lease Information of the Original Lease (the "Premises"). City is using the Premises for office, counseling, public services, and such other uses as specified in the Basic Lease Information.

C. City and Landlord desire to amend the Original Lease to (i) extend the term of the Original Lease, (ii) specify the Base Rent during the extended term, and (iii) make certain other amendments to the Original Lease, all subject to, and on the basis of, the terms, covenants, and conditions of this Amendment. The Original Lease, as amended by this Amendment, is referred in this Amendment to as the "Lease."

ACCORDINGLY, in consideration of the matters described in the foregoing Recitals, and for other good and valuable consideration, the receipt and sufficiency of which are mutually acknowledged, the City and Landlord agree as follows:

1. <u>Definitions</u>. Capitalized terms not otherwise defined in this Amendment have the meanings set forth in the Lease.

2. <u>Amended Basic Lease Information</u>. The subsections in Section 1 (<u>Basic Lease</u> Information) listed below are hereby amended and restated to read in their entirety as follows:

Term (Section 3):	Estimated commencement date:
	July 1, 2016

Expiration date: June 30, 2026

Base Rent (Section 4.1):

Annual Base Rent July 1, 2016 – June 30, 2021: \$177,480 (\$58 per sq. ft.) Monthly payments: \$14,790 (\$4.83 per sq. ft.)

July 1, 2021 – June 30, 2026: \$159,200 (\$52 per sq. ft.) Monthly payments: \$13,260 (\$4.33 per sq. ft.)

Base Rent Adjustment (Section 4.2)	: Base Rent will escalate by 3% on July 1, 2022, and on each July 1 thereafter during the Term.
Extension Options (Section 3.3):	Two (2) additional terms of one (1) year each, exercisable by City by notice to Landlord given not less than one hundred eighty (180) days in advance, with rent equal to 95% of prevailing market rate.

3. <u>Adjustments in Base Rent</u>. <u>Section 4.2</u> of the Original Lease is deleted and replaced with the following:

4.2 Adjustments in Base Rent

On each date specified in the Basic Lease Information for the adjustment of Base Rent (an "Adjustment Date"), the Base Rent payable under <u>Section 4.1</u> (Base Rent) will be adjusted as follows:

On each Adjustment Date, the Base Rent for the following twelve-month period will be adjusted to equal one hundred three percent (103%) of the Base Rent for the lease year preceding the Adjustment Date.

4. <u>No Joint Venture</u>. This Amendment or any activity by the City hereunder does not create a partnership or joint venture between the City and Landlord relating to the Lease or otherwise. This Amendment does not constitute authorization or approval by the City of any activity conducted by Landlord, and the City shall in no way be responsible for the acts or omissions of Landlord on the Premises or otherwise.

5. <u>Attorneys Fees</u>. In the event a dispute arises concerning this Amendment, the party not prevailing in such dispute shall pay any and all costs and expenses incurred by the other party in enforcing or establishing its rights hereunder, including, without limitation, court costs and reasonable attorneys' fees. For purposes of this Amendment, reasonable fees of attorneys of City's Office of the City Attorney shall be based on the fees regularly charged by private attorneys with the equivalent number of years of experience in the subject matter area of the law for which the City Attorney's services were rendered who practice in the City of San Francisco in law firms with approximately the same number of attorneys as employed by the Office of the City Attorney.

6. <u>References</u>. No reference to this Amendment is necessary in any instrument or document at any time referring to the Lease. Any future reference to the Lease shall be deemed a reference to such document as amended hereby.

7. <u>Applicable Law</u>. This Amendment shall be governed by, construed and enforced in accordance with the laws of the State of California.

8. <u>Notification of Prohibition on Contributions.</u> By executing this Lease, Landlord acknowledges its obligations under section 1.126 of the City's Campaign and Governmental Conduct Code, which prohibits any person who leases, or seeks to lease, to or from any department of the City any land or building from making any campaign contribution to (a) a City elected official if the lease must be approved by that official, (b) a candidate for that City elective office, or (c) a committee controlled by that elected official or a candidate for that office, at any time from the submission of a proposal for the lease until the later of either the termination of negotiations for the lease or twelve (12) months after the date the City approves the lease. Landlord acknowledges that the foregoing restriction applies only if the lease or a combination or series of leases or other contracts approved by the same individual or board in a fiscal year

have a total anticipated or actual value of one hundred thousand dollars (\$100,000) or more. Landlord further acknowledges that (i) the prohibition on contributions applies to each prospective party to the lease; any person with an ownership interest of more than 10 percent (10%) in Landlord; any subcontractor listed in the lease; and any committee that is sponsored or controlled by Landlord; and (ii) within thirty (30) days of the submission of a proposal for the Lease, the City department with whom Landlord is leasing is obligated to submit to the Ethics Commission the parties to the lease and any subcontractor. Additionally, Landlord certifies that it has informed each such person of the limitation on contributions imposed by Section 1.126 by the time it submitted a proposal for the lease, and has provided the names of the persons required to be informed to the City department with whom it is leasing.

9. Landlord's Compliance with City Business and Tax and Regulations Code.

Landlord acknowledges that under Section 6.10-2 of the San Francisco Business and Tax Regulations Code, the City Treasurer and Tax Collector may require the withholding of payments to any vendor that is delinquent in the payment of any amounts that the vendor is required to pay the City under the San Francisco Business and Tax Regulations Code. If, under that authority, any payment City is required to make to Landlord under this Lease is withheld, then City will not be in breach or default under this Lease, and the Treasurer and Tax Collector will authorize release of any payments withheld under this paragraph to Landlord, without interest, late fees, penalties, or other charges, upon Landlord coming back into compliance with its San Francisco Business and Tax Regulations Code obligations.

10. <u>**Taxes, Assessments, Licenses, Permit Fees, and Liens.</u> San Francisco Administrative Code Sections 23.38 and 23.39 require that certain information relating to the creation, renewal, extension, assignment, sublease, or other transfer of this Lease be provided to the County Assessor within sixty (60) days after the transaction. Accordingly, Tenant must provide a copy of this Lease to the County Assessor not later than sixty (60) days after the Effective Date, and any failure of Tenant to timely provide a copy of this Lease to the County Assessor will be a default under this Lease.</u></u>**

11. <u>Consideration of Salary History.</u> Tenant shall comply with San Francisco Administrative Code Chapter 12K, the Consideration of Salary History Ordinance or "Pay Parity Act." For each employment application to Tenant for work that relates to this Agreement or for work to be performed in the City or on City property, Tenant is prohibited from considering current or past salary of an applicant in determining whether to hire the applicant or what salary to offer the applicant. Tenant shall not (1) ask such applicants about their current or past salary or (2) disclose a current or former employee's salary history without that employee's authorization unless the salary history is publicly available. Tenant is subject to the enforcement and penalty provisions in Chapter 12K. Information about Chapter 12K is available on the web at https://sfgov.org/olse/consideration-salary-history.

12. <u>Further Instruments</u>. The parties hereto agree to execute such further instruments and to take such further actions as may be reasonably required to carry out the intent of this Amendment.

13. <u>Effective Date</u>. This Amendment shall become effective on the date (the "Effective Date") that (i) the City's Board of Supervisors enacts such resolution authorizing this Amendment and (ii) the Amendment is fully executed and delivered by both parties.

14. <u>Miscellaneous</u>. Except as expressly modified herein, the terms, covenants and conditions of the Lease shall remain unmodified and in full force and effect. The Lease as amended by this Amendment constitutes the entire agreement of the parties concerning the subject matter hereof, and supersedes and conceals any and all previous negotiations,

agreements, or understandings, if any, regarding the matters contained herein. The execution of this Amendment shall not constitute a waiver of relinquishment of any rights which the City may have relating to the Lease. Landlord and City hereby ratify and confirm all of the provisions of the Lease as amended by this Amendment.

NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED IN THIS AMENDMENT, LANDLORD ACKNOWLEDGES AND AGREES THAT NO OFFICER OR EMPLOYEE OF CITY HAS AUTHORITY TO COMMIT CITY HERETO UNLESS AND UNTIL CITY'S BOARD OF SUPERVISORS SHALL HAVE DULY ADOPTED A RESOLUTION APPROVING THIS AMENDMENT AND AUTHORIZING CONSUMMATION OF THE TRANSACTION CONTEMPLATED HEREBY. THEREFORE, ANY OBLIGATIONS OR LIABILITIES OF CITY HEREUNDER ARE CONTINGENT UPON ADOPTION OF SUCH A RESOLUTION, AND THIS AMENDMENT SHALL BE NULL AND VOID UNLESS CITY'S MAYOR AND BOARD OF SUPERVISORS APPROVE THIS AMENDMENT, IN THEIR RESPECTIVE SOLE AND ABSOLUTE DISCRETION, AND IN ACCORDANCE WITH ALL APPLICABLE LAWS. APPROVAL OF THIS AMENDMENT BY ANY DEPARTMENT, COMMISSION OR AGENCY OF CITY SHALL NOT BE DEEMED TO IMPLY THAT SUCH RESOLUTION WILL BE ADOPTED NOR WILL ANY SUCH APPROVAL CREATE ANY BINDING OBLIGATIONS ON CITY.

Dear Board Members:

Attached for your consideration is a Resolution authorizing the amendment of the lease and exercising of the first renewal option of the lease dated for reference purposes as May 6, 2016, by the City for the premises comprising approximately 3,060 square feet with four (4) parking stalls at 650 Fifth St., San Francisco, CA. Since 1999, the premises have been continually used by the Department of Public Health for its Jail Health Services, providing a comprehensive and integrated system of medical, psychiatric and substance abuse services to inmates in San Francisco jails.

The proposed amendment changes the option from three years, to five years and adds two additional extension options of one year each. The purpose of this change is to provide for continual operation of this program and allowing flexibility to relocate the program to City owned property. The lease would become effective, upon approval by the Board of Supervisors and Mayor in their respective sole and absolute discretion.

City shall have two additional one (1) year option periods to extend the lease term based on the same terms and conditions except that the rent shall be adjusted to 95% of the then prevailing fair market rent but in no event less than the Base Rent for the lease year prior to commencement of the option term.

On behalf of the Department of Public Health, the Real Estate Division negotiated the lease at a fair market rent of S 13,260 per month, increasing 3% per year City shall continue to pay for its separately metered electricity. Landlord shall pay the cost of all other utilities and janitorial services.

The Department of Public Health recommends approval of the proposed lease

Hello Supervisors Haney, Safai and Mar,

The Department of Public Health (DPH) and Real Estate and respectfully requesting approval for three (3) leases at the July 21st Budget & Finance Committee meeting. Please see below for lease details, a brief description of each program, and the DPH representatives who may be contacted should you have any questions about the programs.

Agenda item #12 - Lease of Real Property - SFSPE TG, LLC, SFSPE T1, LLC, SFSPE MH, LLC and SFSPE OBI LLC - 1360 Mission Street - \$644,404 Annual Base Rent - Up to \$200,000 in Tenant

Improvements - Resolution approving and authorizing the Director of Property, on behalf of the Department of Public Health, to lease real property located at 1360 Mission Street, for an initial term of four years, from SFSPE TG, LLC, SFSPE T1, LLC, SFSPE MH, LLC and SFSPE OBI LLC, at a base rent of \$644,404 per year with 3% annual increases; authorizing the City to contribute up to an additional \$200,000 in tenant improvements to commence upon substantial completion of the installation of the Tenant Improvements necessary for the City's occupancy, which is expected to occur on or around August 1, 2021; and authorizing the Director of Property to execute documents, make certain modifications and take certain actions in furtherance of the Lease and this Resolution, as defined herein.

• Summary of Lease Details:

- Term: 4 years, two (1) year options to extend, that can be rescinded by notice by Landlord
- Premises: Floors 1 &2 comprised of 16,958 sf.
- Rent: \$38 psf. Initial rate, escalating at 3% per year. \$644,404 base year

- T.I. up to \$200,000 in work to be done prior to rent commencement
- Other concessions: 8 Months of free rent
- Notes: Landlord had been planning redevelopment of this site when the pandemic hit, they have now put their plans on hold and are willing to lease at a steep discount to retain the city as a tenant. The actual rate negotiated was lower than their lender would approve, so free rent was exchanged to make up the difference.
- **Description of Programs**: The 1st floor would be used by approximately 60 grant funded Population Health Covid-related staff, assigned to support the COVID Task Force in the short term as well as continue to manage COVID-19 as an ongoing endemic disease. The 2nd floor would be used by approximately 73 Behavioral Health Services staff, including teams from the Office of Coordinated Care, Street and Justice Services, and Utilization Management. These teams would be responsible for managing and monitoring access, flow, and service utilization throughout the behavioral health system; providing streamlined access to behavioral health services; supporting homeless people with connecting to care and providing direct community-based behavioral health services; providing care coordination services; and providing behavioral health managed care functions.

- Rent: \$52 psf. \$12,260 monthly, \$159,200 annually
- Notes: This is an amendment that was made in place of exercising the renewal option. The original option had rent at \$58 psf. and 3 years of term. DPH is looking to relocate this site to owned space, this additional term provides flexibility to do this, while reducing current rent.
- **Description of Program**: The Department of Public Health currently operates its Jail Health Services (JHS) Administration at 650-Sth Street, Suites 309. The offices serve as the main leadership hub that serves to provide overall comprehensive and integrated system of

medical, psychiatric and substance abuse services to inmates in the San Francisco Jails. As the main Jail Health Services Office, it serves to co-locate the Director of Jail Health, other Leadership and Executive Staff as well as staff who serve as part of the JHS Administration & Operations Team.

Agenda item #14 - Real Property Lease Extension - Mattison Family Trust - 555-575 Polk Street -\$500,364 Annual Base Rent - Resolution approving and authorizing the Director of Property, on behalf of the Department of Public Health, to extend the lease of real property located at 555-575 Polk Street, with Mattison Family Trust, at a base rent of \$500,364 per year with no annual increases, commencing upon the later of August 1, 2021, or approval of this Resolution and expiring on July 31, 2026; and authorizing the Director of Property to execute documents, make certain modifications and take certain actions in furtherance of the Lease and this Resolution, as defined herein.

• Summary of Lease Details:

- Term: 5 years
- Premises: 18,000 sf

- Notes: The annual base rent of \$27.80 per square foot is below fair market rate, and the lack of annual escalation makes the lease more favorable to the City.
- Description of Program: DPH operates the Community Justice Center (CJC) on the second floor, providing court authorized alternatives to incarceration, in partnership with the Superior Court of San Francisco. The CJC includes both a courtroom and social services center. Social services include drug treatment, mental health programs, support groups, counseling, career development, and job training. The AOC and Superior Court are co-occupants of the ground floor premises.
