Dear Members of the Board of Supervisors:

The Office of Economic & Workforce Development (OEWD) is submitting the below information regarding the retroactive Accept & Expend resolution scheduled for the July 27th Board meeting, Agenda item #42 File **[210607](#) Accept and Expend Grant - Retroactive - University of California San Francisco - Construction Community Outreach Program - \$136,000 (Sponsor: Mayor)**.

The UCSF Accept and Expend process was delayed due to the multiple funding sources from the UCSF grant process. The funds have three main purposes and come from three different sources from UCSF. The funds support three programs in CityBuild for staffing and special training. They are CCOP (Community Construction Outreach Program), construction workforce support for the ZSFG-RAB project, and UCSF Special Training for Construction. The Special Training did not happen until the 4th quarter of FY 20-21. For the grant period July 1, 2020 to June 30, 2021, there are three active projects. The volunteer goal is 30% and the projects are ranging from 15-25% of San Francisco residents.

Ken Nim, OEWD's Director of CityBuild will be available to answer specific questions about this grant at the meeting for this item.
