3 **Resolution concurring with the Controller's certification that department services can**
4 **be performed by private contractor for a lower cost than similar work performed by City**
5 **and County employees, for security services (Department of Public Health).**

7 WHEREAS, The Electorate of the City and County of San Francisco passed
8 Proposition J in November 1976, allowing City and County Departments to contract with
9 private companies for specific services that can be performed for a lower cost than similar
10 work by City and County employees (Charter, Section 10.104.15); and

11 WHEREAS, The Controller has determined that a Purchaser's award of a contract for
12 the services listed below to a private contractor will continue to achieve substantial cost
13 savings for the City; and

14 WHEREAS, The Controller's certification, which confirms that said services can be
15 performed at lower costs to the City and County by private contractor than by employees of
16 the City and County, is on file with the Clerk of the Board of Supervisors in File No. 210665,
17 which is hereby declared to be part of this Resolution as if set forth fully herein; now, therefore,
18 be it;

19 RESOLVED, That the Board of Supervisors hereby concurs with the Controller's
20 certification and approves the Proposition J Resolution concerning the Purchaser's award of
21 a contract to a private contractor for the services listed below for the period of July 1, 2021,
22 through June 30, 2022.
