9	WHEREAS, San Francisco is strengthened by robust civic engagement, especially with
10	volunteers who help to maintain public open spaces and help to enhance neighborhood
11	assets for the public good; and
12	WHEREAS, Historically, the City and County of San Francisco grants rights to
13	community groups to create illustrious projects that have become neighborhood attractions
14	such as the Hidden Steps projects on 16th and Moraga and 16th and Kirkham; and
15	WHEREAS, The Public Works Department helps to facilitate dozens of projects across
16	San Francisco to meet the City's Better Streets and Complete Streets Plans, which include
17	community-sponsored landscaping of street medians and streetscapes; and
18	WHEREAS, The San Francisco Arts Commission oversees hundreds of proposals for
19	art placed on City-owned property or City-financed projects on private property; and
20	WHEREAS, While there are programs that support community-sponsored projects on
21	City land; the process for some can be confusing, expensive, and complicated, such as with
22	the Kensington Bridge on Portola Drive and Kensington Way in the West Portal neighborhood
23	the Havelock Bridge on Havelock Street and Circular Avenue in the Sunnyside neighborhood;
24	the Low Acuity Continuing Care facility in the Presidio; and the Richardson Triangle on

Lombard Street in Cow Hollow; and

WHEREAS, For the past few years, West Portal volunteers successfully partnered with	
Public Works to clear up debris and litter at the foot of the Kensington pedestrian bridge and	
establish new plantings, but are facing a long, arduous process to approve a proposal from	
the neighborhood to add a mid-century modern mural on the pillars of the bridge to prevent	
chronic vandalism; and	
WHEREAS, Sunnyside neighbors have volunteered and successfully partnered with	

WHEREAS, Sunnyside neighbors have volunteered and successfully partnered with Public Works to clear up debris surrounding the Havelock bridge, trim overgrown ivy blocking proper safety lighting, establishing new plantings, and partnered with the Municipal Transportation Agency to establish a much-needed crosswalk at the landing that continues to be a concern for pedestrian safety, but are a facing long, arduous process to approve a proposal from neighbors to add a mural that will add to traffic safety and prevent chronic vandalism, and

WHEREAS, Thirteen artists donated 97 murals for the Low Acuity Continuing Care facility in the Presidio, which was built during the COVID-19 pandemic for medical overflow, but was never activated; and after the closure of the site, the murals spent months in limbo despite a great deal of public interest in these works because no City department was willing or able to act a as a steward for the works; thankfully a non-profit partner saved them by volunteering to act as a custodian until the murals could be redisplayed around the City; and

WHEREAS, The Cow Hollow neighborhood has been working on a Lombard Street beautification plan for years and have been met with high administrative barriers in execution; and

WHEREAS, Despite several attempts to convene with staff from various departments, there has not been a clear determination on how best to proceed with these projects due to jurisdictional matters; and

1	WHEREAS, San Francisco's public spaces benefit from the vibrancy of public art
2	projects, especially when initiated by residents and neighbors as it cultivates placemaking and
3	community-building; and
4	WHEREAS, The City and County of San Francisco greatly benefit from private
5	community-public partnerships that help with beautification projects that not only enhance the
6	quality-of-life for residents, but invites visitors and acts as a deterrent to vandalism and blight;
7	now, therefore, be it
8	RESOLVED, That the Board of Supervisors recognizes and applauds the efforts of
9	community members and residents who volunteer their time and crowdsource funds to
10	improve public land that serves the greater good; and, be it
11	FURTHER RESOLVED, That the Board of Supervisors urges the San Francisco Arts
12	Commission, the Department of Public Works, the Bureau of Street Use and Mapping, and
13	the Department of Real Estate, to facilitate and to expedite the issuance of the required
14	permits and permission for the public art installation on the Kensington Bridge and the
15	Havelock Bridge; and be it
16	FURTHER RESOLVED, That the Board of Supervisors urges the City Administrator's
17	office, Arts Commission, the Department of Public Works, the Bureau of Street Use and
18	Mapping, the Department of Real Estate, the San Francisco Municipal Transportation
19	Authority, Recreation and Parks, and the Public Utilities Commission to collaborate and to
20	facilitate a streamlined, clear, and accessible process so that neighborhood groups and
21	community members are able to propose and to fundraise for beautification projects on public
22	land with support and ease.
