INTRODUCTION

The San Francisco Office of Economic and Workforce Development (OEWD) advances equitable and shared prosperity for San Franciscans by growing sustainable jobs, supporting businesses of all sizes, creating great places to live and work, and helping everyone achieve economic self-sufficiency.

A focus will be placed on supporting businesses in Neighborhood Revitalization Strategy Areas (NRSAs) as designated by the U.S. Department of Housing and Urban Development (HUD). NRSAs were established as a means to create communities of opportunity in distressed neighborhoods. The goal is to reinvest in human and economic capital, and economically empower low-income residents as part of an overall community revitalization strategy. San Francisco's six NRSAs are Bayview Hunters Point, Chinatown, Mission, South of Market, Tenderloin and Visitacion Valley neighborhoods. Please see the strategic planning document 2020-2024 Consolidated Plan and 2020-2021 Action Plan for a detailed description of each NRSA.

In addition to the 2020-2024 Consolidated Plan and 2020-2021 Action Plan, OEWD uses the San Francisco Economic Strategy updated in 2014, the State of Retail Sector Study 2018, and the Small Business Needs Assessment 2019 as guides in its pursuit of goals that support the economic vitality of the City and its citizens: creating job opportunities to promote overall economic growth; ensuring inclusion and equity in job opportunities, with an aim at reducing inequality; and ensuring a sound fiscal footing for the City. The combination of these documents make up the Comprehensive Economic Development Strategies (CEDS) that informs the Revolving Loan Fund (RLF) policies and procedures, and RLF strategy. Lending criteria and eligibility requirements are developed and revised according to the CEDS per 13 CFR 307.9(b)(1) and reviewed for consistency on an annual basis.

OEWD and the Loan Administrator will continue to review the performance of the RLF on a semi-annual basis and certify to EDA as required that the RLF plan is consistent with the area's development strategy as defined in the Comprehensive Economic Development Strategy (CEDS) that the RLF is being operated in compliance with the policies and procedures contained in the RLF plan – any exceptions will be noted. The RLF Plan will be amended, as appropriate, to conform to changes in economic conditions and the CEDS. Procedures and policies for Plan modifications of funding source agencies will be followed as relevant and required. Reporting guidelines, procedures and policies of other funding sources agencies will be followed as relevant and required.

The Loan Administrator will follow the Revolving Loan Operational Procedures stated in the current CCSF RLF Operating and Administrative Plan Approved by the Economic Development Administration on July 29 2018. The administrative costs portion of the award will cover the business outreach, technical assistance, and underwriting activities for applicants impacted by local COVID-19 Public Health Orders.

COVID-19 is causing and is expected to continue to cause serious negative impacts on the local economy and financial impacts to local businesses, including significant reductions in income due to lower customer demand or forced closures. These negative impacts will irreparably harm local businesses and the residents they employ. It is in the public interest to take steps to ensure that local businesses can continue to operate and are able to reopen.

Small businesses need access to cash to meet their financial obligations, and pay for ordinary and necessary operating expenses; unfortunately, the reduction in income places a substantial burden on cash flow, and traditional lenders do not fund when there is no clear future of cash flow. In order to respond to the urgent capital needs caused by sudden revenue loss from business disruption we are requesting \$550,000.00 from EDA to help launch the San Francisco Small Business Recovery Loan Program, a flexible loan program created to help businesses recover, reopen, retain employees, and rehire staff.

The San Francisco Small Business Recovery Loan Program will have deferred repayment timing and be otherwise customized to maximize the chances for business survivability and capital recovery. Capital will be deployed to eligible businesses based on certain geographic, business size, and industry criteria. OEWD will work with local CDFIs with deep reach into various communities to support women 'owned, low-income-owned, and minority-owned businesses.

CONCLUSION

The Office of Economic and Workforce Development has a proven track record of managing a revolving loan fund (over \$18 million since 1979), and EDA has made it possible for the OEWD to expand its services, serve more clients, and increase the amount of funds invested in small businesses. Moreover, local businesses would greatly benefit from the additional lending capital during these dire times for small business owners. Investments in the RLF program will greatly assist in the recovery of our local economy and create jobs at a time when unemployment is at an all-time high. As such, we hope that the recovery and economic growth opportunities that
