#### **Budget Narrative:**

The Marine Unit will refurbish the deck and hull (above waterline) of the SFPD marked patrol vessel "SF Marine 7", a 2012 Moose Boats patrol vessel, 37' catamaran with enclosed all weather cabin.

The project includes the removal of all failed paint and deck safety non-skid material surfaces to bare aluminum and replacement with new, high quality safety non-skid on all applicable deck surfaces. All other surfaces will be left bare aluminum to negate future repainting requirements. These processes will provide safe use of vessel deck for both normal crew working in wet conditions, as well as rapid deployed special operators utilizing the deck as a launch platform for tactical assault missions.

This work will correct deck and hull protection coating deficiencies and allow 8-10 years of continued vessel service life.

Recipients must ensure that project activities carried on outside the United States are coordinated as necessary with appropriate government authorities and that appropriate licenses, permits, or approvals are obtained.

Our resolution is retroactive because we were working with FEMA on approval of a local cost match waiver. With the impacts from the COVID-19 pandemic, we could no longer meet the grant match requirement and submitted a waiver request. The request was approved by FEMA in February 2021 and an amended budget was approved on April 23<sup>rd</sup>. The accept and expend resolution is for the reduced budget amount of \$1,161,830 and the grant performance period still has a start date of September 1, 2020, hence the requirement for the resolution to be retroactive.
