1	[Settlement of Lawsuit - Francis and Julio Osorio - \$225,000]		
2			
3	Ordinance authorizing partial settlement of the lawsuit filed by Francis and Julio Osorio		
4	against the City and County of San Francisco for \$225,000; the lawsuit was filed on		
5	August 20, 2015, in San Francisco Superior Court, Case No. CGC-15-547492; entitled		
6	David Alfaro, et al. v. City and County of San Francisco; the lawsuit involves inverse		
7	condemnation arising out of flooding damage during major rainstorms in December of		
8	2014; this settlement relates only to the diminution of real property value claims of		
9	plaintiffs Francis and Julio Osorio, and does not include claims for property loss or for		
10	attorney's fees, costs and interest.		
11			
12	Be it ordained by the People of the City and County of San Francisco:		
13	Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby		
14	authorizes the City Attorney to settle in part, and only as to plaintiffs Francis and Julio Osorio,		
15	the action entitled David Alfaro, et al. v. City and County of San Francisco, San Francisco		
16	Superior Court, Case No. CGC-15-547492 by the payment of \$225,000 to plaintiffs Francis		
17	and Julio Osorio. The lawsuit involves inverse condemnation arising out of flooding damage		
18	during major rainstorms in December of 2014.		
19	Section 2. The above-named action was filed in San Francisco Superior Court on		
20	August 20, 2015. This is an action brought by owners or occupants of several dozen		
21	properties located in San Francisco against defendant City and County of San Francisco.		
22	Section 3. This is a partial settlement of the action. It resolves the diminution of real		
23	property value claims of commercial property owning plaintiffs Francis and Julio Osorio. The		
24	parties have previously, separately settled the personal and real property damage claims of all		
25	property owners and diminution in value claims of residential property owners in this action.		

1	The parties will subsequently and separately address all claims for statutory attorney's fees
2	relating to this action.
