4 **the City and County of San Francisco for \$100,000; the lawsuit was filed on June 25,**
5 **2020, in San Francisco County Superior Court, Case No. CGC-20-585036; entitled**
6 **Nadezhua Oshmansky v. City and County of San Francisco et al.; the lawsuit involves**
7 **alleged personal injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Nadezhua Oshmansky v. City and
12 County of San Francisco et al., San Francisco County Superior Court, Case No. CGC-20-
13 585036 by the payment of \$100,000. The lawsuit involves alleged personal injury on a City
14 sidewalk.

15 Section 2. The above-named action was filed in San Francisco County Superior Court
16 on June 25, 2020, and the following parties were named in the lawsuit: plaintiff Madezhua
17 Oshmansky, and defendants City and County of San Francisco, AT&T, Inc.; and Does 1
18 through 50.
