I was born in San Francisco. I have lived in Hayes Valley for the past 2 years (Fulton/Octavia) and recently moved to 1 Polk Street. I am a gay, cis-male, Chinese-American nonprofit worker. I have been a member of the Harvey Milk LGBTQ Democratic Club since 2016. Currently, I am the Vice President of the Rose Pak Democratic Club, working to uplift the voices of the San Francisco's API communities and other marginalized groups. As a nonprofit worker, I am low-income. I have lived some of the struggles that low-income communities experience in the face of rising rents and living expenses.

#### Business and/or professional experience:

For the past 4 years, I've worked for Chinatown Community Development Center, a nonprofit housing developer that focuses exclusively on providing low-income housing to San Franciscans. In my current role as Asset Management Coordinator, I analyze the financials of the buildings in our portfolio, which consists of 3,000 units across 35 properties in San Francisco. Through providing housing to low-income communities, I have seen first hand the financial struggles they face. Most of our residents are working class families or live on a fixed income and have been severely affected by the pandemic. I also understand the necessity of community-centered urban development. Far too often are local communities treated as an afterthought or completely ignored in the planning process.

The CAC will be advisory, as appropriate, to the Planning Director, the Interagency Plan Implementation Committee, the Planning Commission, and the Board of Supervisors. Planning Code Section 341.5 provides that the Planning Department or Interagency Plan Implementation Committee shall designate necessary staffing from relevant agencies to the CAC, as needed to complete the CAC's responsibilities described in this Code. To the extent permitted by law, staffing for the CAC shall be funded through the Market & Octavia Community Improvements Fund administration fees.

The CAC may perform the functions enumerated in Planning Code Section 341.5(a) as needed. The CAC shall consist of 9 members. Every member of the CAC must live or work within the Plan Area. The appointing authority shall use best efforts to appoint members from varying geographic, socio-economic, ethnic, racial, gender, and sexual orientations. The Mayor shall appoint one-third (3) of the members of the CAC. The Board of Supervisors shall appoint two-thirds (6) of the members and at least one shall be a resident renter, one a resident homeowner, one a low-income resident, one a local merchant, one a representative of established neighborhood groups and one member at large.

The members of the CAC shall serve at the pleasure of the appointing authority for a term of two years from the date that all nine members have been appointed.
