4 **City and County of San Francisco for \$165,000; the lawsuit was filed on April 29, 2019,**
5 **in San Francisco Superior Court, Case No. CGC-19-575558; entitled Stephanie Brunton**
6 **v. City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**
7 **on a City crosswalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Stephanie Brunton v. City and County
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-19-575558 by the
13 payment of \$165,000. The lawsuit involves personal injury on a City crosswalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April
15 29, 2019, and the following parties were named in the lawsuit: Plaintiff: Stephanie Brunton;
