Resolution Calling for the Creation of a "Beach to Bay" Car-Free Connection and
 Urging the Recreation and Park Department and San Francisco Municipal

5 Transportation Agency to Improve Park Accessibility and Create Equitable Access to 6 Golden Gate Park.

8 WHEREAS, Golden Gate Park is the third most visited park in the United States as 9 green space used by 13 million people each year; and

WHEREAS, In 1998, the Golden Gate Park Master Plan was adopted, which set a long
 term vision for park investments, including creating and maintaining a parkwide system of
 recreational roadways, pathways, and trails, and to minimize motor vehicle traffic; and
 WHEREAS, Also in 1998, Proposition J - Golden Gate Park Revitalization Act
 established the Concourse Authority to oversee the construction of privately funded
 Concourse Garage and related, publicly funded transit improvements; and

16 WHEREAS, Starting in 1969, the eastern half of John F. Kennedy (JFK) Drive was
17 closed to cars every Sunday; and

WHEREAS, In 2007, then-Supervisor Jake McGoldrick in File No. 070489, on file with the Clerk of the Board of Supervisors in File No. 210944, which is hereby declared to be a part of this resolution as if set forth fully herein, established "Healthy Saturdays," closing certain roads in Golden Gate Park including the eastern half of JFK Drive on Saturdays between April and September; and

23 WHEREAS, In 2005, the Board of Supervisors passed a Resolution File No. 051247, 24 on file with the Clerk of the Board of Supervisors in File No. 210944, which is hereby declared 25 to be a part of this resolution as if set forth fully herein, approving the Golden Gate Park Music Concourse Surface Circulation Plan which prohibited the use of the Music Concourse for cut through automobile traffic; and

WHEREAS, On April 27, 2020, under the public health emergency order, to allow residents to exercise and maintain a physical distance from others during the COVID-19 pandemic, a few roads in Golden Gate Park traveling from east to west were closed to cars, creating a bicycle and pedestrian pathway from the beach to the far east side of the park, including JFK Drive between Kezar Drive and Transverse Drive; and

8 WHEREAS, In working with the city government, the M.H. de Young Memorial Museum 9 (de Young) built its loading docks on JFK Drive when rebuilding the institution, allowing for 10 freight delivery trucks to enter JFK Drive from the north in order to reach the museum's 11 loading docks, and the arrangement will continue to be monitored, evaluated, and modified for

12 effectiveness and safety; and

WHEREAS, The western half of JFK Drive is on the Vision Zero High Injury Map, and
since the road closures on Martin Luther King Jr. (MLK) Drive and JFK Drive, there have not
been any reported collisions of bicyclists or pedestrians; and

16 WHEREAS, Bicycle and pedestrian safety improvements have been continually made 17 in Golden Gate Park, including through the Golden Gate Park Safety Project, and safety 18 infrastructure encourages people to travel to and through the park using sustainable modes of 19 transportation; and

20 WHEREAS, Due to the closure of the Great Highway, travel patterns modeled by the 21 San Francisco County Transportation Authority (SFCTA) shows vehicle traffic increasing on 22 Chain of Lakes and therefore pushing cars into Golden Gate Park; and

WHEREAS, The Golden Gate Park Sustainable Travel Study working group was
 created to address the diverse needs of stakeholders of JFK Drive and identify access needs
 for the eastern half of the road; and

1 WHEREAS, Common values of the working group included equal access for people 2 with disabilities, elders, families, those living outside the Richmond or Sunset, tourists, and 3 business people, and safety for bikers, walkers, museum and park employees during the day 4 and night; and

5 WHEREAS, Senior, disabled, and limited mobility communities have long faced 6 barriers due to automobile-exclusive infrastructure that prohibits or discourages pedestrian 7 use altogether, and can face additional barriers with road closures and often 8 underrepresented in conversations regarding accessibility; and

9 WHEREAS, Communities historically redlined and lack access to open space given 10 decades of systemic disinvestment in the parks in those communities, including the Bayview, 11 Hunters Point, Chinatown, and Sunnydale, face barriers to visiting distant civic destinations 12 such as Golden Gate Park and may have to choose between an hour long bus ride or driving 13 a car to access these open spaces; and

WHEREAS, Other modes of sustainable transportation may not be as easy,
accessible, or affordable for these historically underserved communities; and

WHEREAS, Several institutions in Golden Gate Park draw millions of visitors in prepandemic years including the Japanese Tea Garden, de Young Museum, and California Academy of Sciences, serving not only San Francisco residents of all ages and abilities, but also non-residents and regional tourists who may be relying upon a vehicle to access the museums and gardens; and

21 WHEREAS, The parking garage prices may not be affordable for all park and museum 22 visitors, especially San Francisco residents in underserved communities, and free parking on 23 JFK Drive is not available when the road is closed to vehicles; and

24 WHEREAS, San Francisco's General Plan includes policies to: reduce congestion by 25 encouraging alternatives to single occupant vehicles and ensure the safety and comfort of pedestrians, and identifying and expanding recreational bicycling activities, and implementing
 the provisions of the Americans with Disabilities Act (ADA) and the city's curb ramp program
 to improve pedestrian access for all people; and

WHEREAS, A draft map is on file with the Clerk of the Board of Supervisors in File No.
210944, which is hereby declared to be a part of this Resolution as if set forth fully herein; and

6 WHEREAS, The Board of Supervisors acknowledges that nothing in this resolution 7 constitutes a definitive commitment to a specific course of action, and that some actions urged 8 herein may be modified, and may need to undergo public deliberation and process and 9 environmental review before being implemented; and; now, therefore, be it

10 RESOLVED, The Board of Supervisors supports the creation of a "Beach to Bay" path 11 utilizing the existing road closures in Golden Gate Park for pedestrians, cyclists, and other 12 non-motor vehicles to access and travel separately from motor vehicles, starting from MLK 13 Drive and La Playa Street, to Middle Drive West, to Overlook Drive, connecting at JFK Drive 14 and Transverse Drive though to Kezar Drive at Stanyan Street; and

FURTHER RESOLVED, That the Board of Supervisors supports equitable and
 affordable access to parks, open areas, and recreation, and urges SFMTA and the Recreation
 and Park Department (RPD) to increase accessibility to these areas for low-income,

18 historically underserved communities; and, be it

FURTHER RESOLVED, That the Board of Supervisors acknowledges SFMTA and RPD have begun outreach to stakeholders to identify challenges and concerns in safely accessing Golden Gate Park, and urges the agencies to conduct transparent and equitable community outreach and engagement to be incorporated in any future changes to Golden Gate Park; and

FURTHER RESOLVED, That the Board of Supervisors urges the de Young and
 California Academy of Sciences to work with city departments to continue to improve
 equitable access to their institutions; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to
collect and monitor data on Golden Gate Park users to ensure racial, socioeconomic, mobility,
and health equity for all users; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to
collect data on vehicle travel through Golden Gate Park in north-south directions, to establish
metrics in data collection for the purpose of ensuring bicycle and pedestrian safety, and reevaluate if the managed access is not meeting safety; and

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to implement both short- and long-term strategies identified in the Golden Gate Park Sustainable Travel Study including, but not limited to, improved wayfinding signage and park maps, such as park shuttle stops, garage signage with parking availability for the Concourse garage, improve in-park mobility services, and improve and prioritize connections and access points into the park; and

17 FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to 18 provide diverse and affordable transit options including, but not limited to, an accessible, 19 affordable, timely, and reliable Golden Gate Park shuttle that connects with nearby high 20 frequency transit (e.g. N-Judah, 5R-Fulton Rapid, and others), more frequent and reliable 21 cross-town routes, improvements to North-South connections on the westside of San 22 Francisco by all modes of transit, including implementing improvements for connections to 23 Sunset Boulevard, bus lines including the 29-Sunset, 28-19th Avenue, 18-46th Avenue, restoration of the 21 Hayes which provides the Western Addition and other city residents with 24 a direct connection to Golden Gate Park at Fulton and Stanyan Street during the weekday 25

and 8th Avenue and Fulton on weekends, and safety improvements for pedestrians and
 cyclists at Chain of Lakes; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges the SFMTA to fulfill
pedestrian safety improvements on surrounding streets to Golden Gate Park including, but not
limited to, Fulton Street, Lincoln Way, accessible park border sidewalks on Lincoln Way, and
to make additional safety improvements at the park entrance at Stanyan Street and Kezar
Drive for pedestrians and cyclists; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to 9 improve garage signage and parking availability, and wayfinding outside of the park so visitors 10 are aware garage access is free for the first 15 minutes and can drop off passengers inside 11 the garage; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to implement options on providing free parking for the first four hours in the Music Concourse garage for San Francisco residents in ZIP codes that are historically low-income, underserved residents including 94124, 94112, 94108, 94134, and 94133, or by proof of Electronic Benefits Transfer (EBT) or Medi-Cal card; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges RPD to explore and implement incentives for San Francisco residents in low-income or isolated communities to visit Golden Gate Park, such as providing designated weekend public transit to the Music Concourse for San Francisco residents including 94124, 94112, 94108, 94134, and 94133; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to add additional ADA parking in and provide free parking for the first four hours in the Music Concourse garage for vehicles with a Disabled Person Placard, as seniors and people with disabilities may experience more economic hardships; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to implement a comprehensive curb management strategy for the Music Concourse and surrounding streets to allow for access to the loading dock for the institutions, and to improve parking availability for institution employees who may work late hours; and, be it FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to develop options for considering managed access at 8th Avenue and Fulton Street to allow for vehicles actively transporting seniors, people with disabilities, and visitors with limited mobility; and, be it FURTHER RESOLVED, That the Board of Supervisors urges SFMTA and RPD to allow for vehicle access on Conservatory Drive West via Arguello Street so volunteers of the Dahlia Dells and Conservatory of Flowers may access the area; now, therefore be it FURTHER RESOLVED, That the Board of Supervisors hereby directs the Clerk of the Board to transmit a copy of this Resolution to the Mayor, RPD, and SFMTA.
