18 of established neighborhood groups and live or work within the Plan area, for the unexpired
19 portion of a two-year term ending December 16, 2022;

20 Tracy Jacks, Seat 6, succeeding Jason Henderson, term expired, must be a member
21 at-large and live or work within the Plan area, for the unexpired portion of a two-year term
22 ending December 16, 2022.


