18	that event, after the sunset date, the City Attorney shall cause this Article XXXVIII to be
19	removed from the Administrative Code.

21	Section 2. Effective Date. This ordinance shall become effective 30 days after
22	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
23	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
24	of Supervisors overrides the Mayor's veto of the ordinance.
