1	[Supporting Notice and Compliance Opportunities for Small Businesses Facing Lawsuits or Violations Related to Americans with Disabilities Act Accommodations]

3	Resolution stating that the City and County of San Francisco supports notice and
4	compliance opportunities for small businesses facing lawsuits or violations related to
5	Americans with Disabilities Act accommodations; and calling for additional support,
6	assistance, and information for Small Businesses to comply with the American with
7	Disabilities Act.

9	WHEREAS, The Americans with Disabilities Act has played a critical role in protecting
10	people with disabilities from discrimination in employment, transportation, and access to any
11	facilities open to the public; and
12	WHEREAS, Passed in 1990, the Americans With Disabilities Act did not assign a
13	federal agency to enforce its requirements; and
14	WHEREAS, Under existing federal law, a defendant is deemed liable for damages for
15	each instance of discrimination relating to a construction-based accessibility standard; and
16	WHEREAS, The private right of action to enforce ADA does have an important role in
17	ensuring compliance, yet there is a trend of lawsuits being filed against small businesses to
18	extort settlements in ways that do not actually expand access for the disabled; and
19	WHEREAS, Two plaintiffs have filed over 1,000 combined Americans With Disabilities
20	Act (ADA) lawsuits across California since the pandemic began; and
21	WHEREAS, Small businesses in San Francisco, and particularly in Chinatown, are still
22	recovering from pandemic but are the hardest hit by these financially burdensome lawsuits
23	which can at times cause them to go deep in debt, or even go out of business; and
24	WHEREAS, Senate Bill 269 was signed into law by California Governor Jerry Brown in
25	2016, and gives small businesses the important opportunity to fix ADA violations before

1	getting sued under state law; small businesses with less than 50 employees are now required
2	to be given both notice and time to cure the violation before facing penalties under state law;
3	and
4	WHEREAS, The opportunities to correct violations before facing lawsuits and penalties
5	still does not exist under federal law, in particular the procedural mechanisms imposed by
6	state law under SB 269 are generally not followed by federal courts; and
7	WHEREAS, San Francisco Mayor London N. Breed has expressed concern about
8	predatory ADA lawsuits and their impact on small businesses and subsequently allocated city
9	funds to help businesses conduct American with Disabilities Act compliance inspections and
10	bring merchants up to code; and
11	WHEREAS, San Francisco District Attorney Chesa Boudin has launched a criminal
12	investigation into the series of lawsuits and assembled an advisory task force to support small
13	businesses that are facing ADA lawsuits; now, therefore, be it
14	RESOLVED, The San Francisco Board of Supervisors supports small businesses
15	being provided with notice and opportunities to correct a violation before facing lawsuits or
16	statutory damages, and condemns predatory lawsuits that target vulnerable small businesses;
17	and
18	FURTHER RESOLVED, The San Francisco Board of Supervisors supports the
19	Americans with Disabilities Act, and to fully actualize its goals, by providing adequate and
20	effective outreach, support, and accountability for small businesses to ensure that all people
21	have full access to facilities open to the public; and
22	FURTHER RESOLVED, California law, under SB 269, offers critical opportunities for
23	notice and correction for small businesses when faced with potential ADA violations, and
24	similar provisions should be considered for inclusion within federal law; and

1	FURTHER RESOLVED, Additional support should be provided by every level of
2	government for small businesses that face these lawsuits, to provide them with assistance,
3	information, resources, and also that they can cure any violations and effectively ensure
4	access for the disabled; and
5	FURTHER RESOLVED, Additional steps should be taken to provide oversight and
6	accountability for attorneys that engage in predatory ADA lawsuits; and
7	FURTHER RESOLVED, Copies of this Resolution will be distributed to San Francisco's
8	federal and state elected representatives and the Attorney General of the State of California.
