I am a 35 year resident of North Beach in San Francisco and laundromat user. As a renter I do not have laundry facilities in my building, a situation shared by many of the senior renters in this neighborhood.

Laundromats provide essential services to people who don't have access to in-unit washer and dryers, or to laundry services in their building.

It is troubling to hear that nearly one-in-three San Francisco Laundromats have closed down in the past decade.

If my Laundromat closed down, I would face substantial hardship. Even walking a few extra blocks to the next-closest laundromat presents challenges due to mobility issues. Also on a fixed income I cannot afford to have my laundry sent out.

I work at a grocery store, and we no longer give rolls of guarters to our customers. Wells Fargo will not give out quarters even though I've been their customer for over 20 years. Even though it's a circulation issue and not a "shortage", the fact remains that people can't easily do laundry without quarters. My building has coin-op laundry. If no one has quarters to use in the machines, I can see my landlord trying to remove the washers & dryers under the guise of "lack of use". My only option would be to haul my clothes to a laundromat that takes debit cards. That would be very difficult for me to do as I'm injured, and it is a hilly walk. Not to mention that as a woman, I don't feel safe in unattended laundromats, especially during early hours when I would need to go. Further, laundromats are more expensive than the machines in my building. All these things severely limit my options for clean clothes during a pandemic. Please stop landlords from removing laundry facilities. If you can't, could you please at least force the ones who do to give a reasonable rent reduction--one that equals what it would take for laundry wash & fold, including

pick-up & drop-off, subject to change as the cost of such services goes up. That would still be hard for me because I have skin allergies that would cause those services to charge me more for the extra care & services that I need, such as using sensitive detergents. Lastly, forcing me to use a service would still mean I couldn't di my delicates, which need to air dry. Most laundry services don't offer that option. Air drying is also better for the environment. Such services also don't use hot water unless you pay extra. my doctor recommended that I wash all bedding & sheets in very hot water. Thank you for reading this...
