12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Chapter 5, Article XXXIII, of the Administrative Code is hereby amended by  
14 revising Section 5.38-8, to read as follows:

15 **SEC. 5.38-8. SUNSET DATE.**

16 Unless the Board by ordinance extends the term of the Committee, this Article XXXVIII  
17 shall expire by operation of law, and the Committee shall terminate, ~~three years after the~~  
18 ~~effective date of the ordinance in Board File No. 180800 enacting this Article~~ on January 1, 2025. In  
19 that event, after the sunset date, the City Attorney shall cause this Article XXXVIII to be  
20 removed from the Administrative Code.

21 Section 2. Effective Date. This ordinance shall become effective 30 days after  
22 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
23 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
24 of Supervisors overrides the Mayor's veto of the ordinance.

1 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
2 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
3 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
4 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
5 additions, and Board amendment deletions in accordance with the "Note" that appears under  
6 the official title of the ordinance.
