3 **Ordinance authorizing settlement of the lawsuit filed by David Joslyn against the City**  
4 **and County of San Francisco for \$3,250,000; the lawsuit was filed on October 2, 2019,**  
5 **in San Francisco Superior Court, Case No. CGC-19-579230; entitled David Joslyn, et al.**  
6 **v. City and County of San Francisco, et al.; the lawsuit involves alleged personal injury**  
7 **from medical negligence; other material terms of the settlement are that Iris Solano,**  
8 **Frederick Stewart Joslyn and Iris Lorraine Solano waive any potential future claims for**  
9 **wrongful death.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes  
13 the City Attorney to settle the action entitled David Joslyn, et al. v. City and County of San  
14 Francisco, et al., San Francisco Superior Court, Case No. CGC-19-579230 by the payment  
15 of \$3,250,000 and that Iris Solano, Frederick Stewart Joslyn and Iris Lorraine Solano waive  
16 any potential future claims for wrongful death. The lawsuit involves alleged personal injury  
17 from medical negligence.

18 Section 2. The above-named action was filed in San Francisco Superior Court on  
19 October 2, 2019, and the following parties were named in the lawsuit: Plaintiffs David Joslyn  
20 and Iris Solano; Defendants City and County of San Francisco, Paul Hausknecht, Louis Yu,  
21 Dwayne Adams, Grace Massa, Chelsea Nash, and Brian Cross.
