Ordinance appropriating \$23,711,912 \$20,807,609, including appropriating \$22,828,000\$19,923,697 of surplus San Francisco General Hospital revenues and \$7,500 of Laguna Honda Hospital revenues, de-appropriating \$876,412 of Laguna Honda Hospital and non-hospital operations expenditures, to fund cost overruns in the Department of Public Health, including \$16,280,391 \$13,258,088 at San Francisco General Hospital, \$6,058,521 \$6,176,521 at Laguna Honda Hospital, and \$1,373,000 in non-hospital operations, for FY2009-2010.
