WHEREAS, Sacred Heart <u>Cathedral</u> Preparatory will pay all necessary rental fees for weekend use, now, therefore, be it

Supervisor Avalos, Elsbernd BOARD OF SUPERVISORS RESOLVED, That the Board of Supervisors approves the Gift and authorizes the Recreation and Park Department General Manager to accept the Gift, and to perform all acts required of the City thereunder; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Recreation and Park General Manager to enter into any modifications to the Gift that the Recreation and Park General Manager determines, in consultation with the City Attorney, are in the best interests of the City and do not materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the Gift or this Resolution, and are in compliance with all applicable laws, including the City's Charter.
