7 WHEREAS, In each year, the Board of Supervisors shall designate the official
8 newspaper of the City and County of San Francisco, pursuant to Section 2.80-1 and 2.81 of
9 the San Francisco Administrative Code; now, therefore, be it

10 RESOLVED, That the Examiner and the San Francisco Chronicle, newspapers of
11 general circulation published in the City and County of San Francisco for the dissemination of
12 local or telegraphic news and intelligence of a general character, having a bona fide
13 circulation of at least 50,000 copies per calendar week, are hereby designated as official
14 newspapers of the City and County of San Francisco for the publication of all official
15 advertising (Type 1 and Type 2) of the City and County for FY2010-2011; and, be it

16 FURTHER RESOLVED, That the Office of Contract Administration is hereby
17 authorized to enter into contracts with the Examiner and the San Francisco Chronicle and said
18 contracts must be in accordance with all the contracting requirements of the City and County
19 of San Francisco.




