**170781 [Administrative Code - Maya Angelou Statue at Main Library - City Policy Regarding Depiction of Women on City Property - Women's Recognition Public Art Fund]**

**Sponsor: Farrell**

Ordinance directing the Arts Commission to erect a statue of Maya Angelou at the Main Library; setting a City policy that at least 30% of nonfictional figures depicted or commemorated in statues and other works of art on City-owned property, public building names, and street names, be women; amending the Administrative Code to create a fund to accept gifts to pay for the design, construction, repair, maintenance, and improvement of public art depicting historically significant women on City property; and affirming the Planning Department's determination under the California Environmental Quality Act.

### **171317 [Health Code - Banning Sale and Manufacture of Animal Fur Products]**

**Sponsor: Tang**

Ordinance amending the Health Code to ban the sale in San Francisco of animal fur products.

12/12/17; ASSIGNED UNDER 30 DAY RULE to Public Safety and Neighborhood Services Committee, expires on 1/11/2018.

12/20/17; REFERRED TO DEPARTMENT. Referred to the Department of Public Health, the Controller, and the Treasurer & Tax Collector for informational purposes; and the Small Business Commission for comment and recommendation.

*Heard in Committee. Speakers: Supervisor Katy Tang (Board of Supervisors); presented information and answered questions raised throughout the discussion. Richard Shulke; Almira Tanner, and Wayne Hsiung (Compassionate Bay); Ashley Byrne (PETA); Sonia Huang; spoke in support of the hearing matter. Stanley Pas, and Deborah Pas (West Coast Leather); spoke in opposition of the hearing matter.*

**Member Fewer moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING NEW TITLE, by editing the findings and purpose contained in new Section 1D.2, on Page 1, Lines 18-22, by inserting '(a) Historically, animals were hunted or trapped for food, and their pelts were used to provide protective clothing. Over time, civilizations and technology have developed such that fur is less of a necessity and more of a luxury. Fur garments are now typically designed for fashion rather than warmth. Further, more animals are now killed to make decorative fur trim than to manufacture full fur garments'; on Page 1, Lines 23-24, by inserting 'Major producers of fur include the United States, Canada, and Scandinavian countries'; on Page 2, Lines 1-8, by inserting '(c) More than 85% of pelts in the world's fur trade come from fur farms. The remaining 15% are from animals caught in the wild. Animals that are bred on fur farms commonly include mink, fox, marten, and chinchilla. (d) The majority of pelts produced annually are mink. In 2013, approximately 275 mink farms in 23 states across the United States produced about 3 million pelts, with an aggregate value of over \$300 million. As of 2015, mink pelt production in the United States totaled 3.76 million pelts. Mink pelt production in the United States saw a sharp increase between 2011 and 2014, but has since remained stable'; on Page 2, Lines 9-13, by striking 'A vast majority—about 85%—of fur fashion products are made with pelts sourced from animal fur factory farms. (b) Animals raised on such fur farms typically spend their lives in cramped cages, and are subject to cruel and filthy living conditions. Methods frequently used on fur farms to kill livestock for their pelts include gassing, electrocution, poison, and neck-breaking'; on Page 2, Lines 14-16, by inserting '(e) Fur farming can be damaging to the environment and contributes to water and air pollution. Fur processing often involves use of harmful chemicals including chromium and formaldehyde'; on Page 2, Lines 21-23, by inserting '(g) Existing laws require relatively little oversight of the fur farming and fur trade industries. Compliance with guidelines issued by the American Veterinary Medical Association is not mandatory, and fur farms are not monitored by any government agency'; on Page 3, Lines 1-3, by inserting ' (h) Federal law does forbid deceptive labeling of fur products, and requires that products made with real fur be labeled as such. This allows consumers to choose whether to purchase real or faux fur garments'; by changing the operative date in Section 1D.4 from July 1, 2018 to January 1, 2019; on Page 4, Lines 3-4, by inserting 'Beginning January 1, 2019, it shall be unlawful to manufacture a Fur Product in San Francisco'; on Page 4, Line 7 by striking 'Fur Products by a Non-profit Organization; or'; on Page 4, Lines 13-14, by inserting '(d) The prohibition in subsection (b) shall not apply to the manufacture of any Fur Product using Fur sourced exclusively from Used Fur Products'; and making other conforming and clerical changes.
