- 4. Inquire into whether property owned and operated by the Port of San Francisco, Redevelopment Agency, and other City Departments could be utilized to temporarily and/or permanently house arts and non-profit organizations.
- 5. Inquire into the other local, state and federal funding mechanisms that displaced arts and non-profit organizations can access.
- Devise other additional strategies to prevent arts and non-profit organizations from being displaced.
- 7. Determine the future cultural and social impact to the San Francisco arts, music and dance scene from the rapid displacement and eviction of various arts organizations.
