- 1.) Department heads from the aforementioned City departments will provide information of why overtime requests from 318 police officers, 135 firefighters, 26 sheriffs, 25 San Francisco Water Department staff, and 24 MUNI staff were approved.
- 2.) Inquire into whether such overtime requests were necessary or appropriate and to determine the fiscal impact for fiscal year 2000-01.
- 3.) Examine management strategies to reduce the amount of overtime requests, approve overtime request only

where appropriate and necessary.
